**About the Hanger Charitable Foundation Scholarship** – The Hanger Charitable Foundation is interested in helping children with limb loss or limb difference get to Camp No Limits. In 2016, Hanger, Inc. donated \$100,000 to create scholarships for first-time campers (plus one parent/ guardian per camper), returning families and teen mentors to attend any of the 2016 Camp No Limit camps. They have granted to the same funds for Camp No Limits’ 2017 season!

**Details:** The value of each Hanger Charitable Foundation Scholarship is \$1,000. Each scholarship covers the cost of attendance for two individuals (\$500 for the camper; \$500 for one parent/guardian) at one 2017 Camp No Limits camp and includes lodging, meals, and most activities at that camp. The Hanger Charitable Foundation Scholarship does not cover the cost of travel/transportation to and from the camp, or any discretionary purchases such as camp merchandises, raffles, and ancillary activities.

**Selection process:** The Camp No Limits staff will manage the 2017 Hanger Charitable Foundation Scholarship application process, select the scholarship recipients, and communicate the scholarship selections to the parents/children. The Hanger Charitable Foundation Scholarship is eligible to children under the age of 18 years old at the time of application who have limb loss or limb difference. Preference will be given to first time campers.

**Disclosure:**

- The Hanger Charitable Foundation (“**the Foundation**”) has generously funded the Hanger Charitable Foundation Scholarship with a contribution to Camp No Limits. Camp No Limits solely determines scholarship winners. The Foundation is not responsible for the operations and activities of Camp No Limits. Please note that the Hanger Charitable Foundation Scholarship is a separate scholarship opportunity in addition to the scholarship application embedded in the camp application process online; individuals are allowed to apply for both scholarships.
- In exchange for receiving the Scholarship, recipients will be asked to provide a publicity release form to Camp No Limits and the Hanger Charitable Foundation to use both photos and stories from Camp No Limits in communication and promotional materials.
- **RELEASE.** By entering, applicant agrees to accept and abide by the terms and conditions of the Hanger Charitable Foundation Scholarship as set forth herein and by Camp No Limits from time to time and agrees that any dispute with regard to the conduct of the Hanger Charitable Foundation Scholarship, rule interpretation, or award of scholarships shall be submitted to Camp No Limits, whose decision shall be binding and final. By participating, applicant agrees to release and hold harmless Camp No Limits, the Foundation, Hanger Inc., Hanger’s participating dealers and retailers, affiliates, sales representatives, distributors and promotional and other vendor agencies, their respective parent companies, affiliates, subsidiaries, service agencies, independent contractors, and the officers, directors, employees, agents and representatives of any of the above organizations from any injury, loss or damage to person, including death, or property due in-whole or in-part, directly or indirectly, to the acceptance or use/misuse of a scholarship, participation in any scholarship activity, or participation in Camp No Limits.

- **DISPUTES.** Each applicant agrees that (1) any and all disputes, claims, and causes of action arising out of or in connection with this scholarship, or any scholarships awarded, shall be resolved individually, without resort to any form of class action, and any judicial proceeding shall take place in a federal or state court in Austin, Texas; (2) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this scholarship, but in no event attorneys' fees and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental, and consequential damages, and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of the rules, or the rights and obligations of applicant and Camp No Limits, the Foundation and Hanger Inc., in connection with this sweepstakes shall be governed by, and construed in accordance with the laws of the State of Texas, without giving effect to any choice of law or conflict of law rules or provisions (whether of the State of Texas or any other jurisdiction), that would cause the application of the laws of any jurisdiction other than those of the State of Texas.

I indemnify, hold harmless and forever release and discharge Hanger from any and all claims, liabilities, damages or expenses (including attorneys fees' and disbursements) arising out of, in connection or otherwise relating to the use of the Media, Statements and/or Personal Information, whether for defamation, violations of privacy rights, infliction of emotional distress or anything else.

This authorization and release shall inure to the benefit of Hanger and to its licensees and assigns.
